



Website Privacy Statement

Vermilion Energy ("**Vermilion**") is committed to respecting the privacy of visitors to our website and remains committed to ensuring its compliance under applicable international and local privacy legislation. In compliance with these obligations, Vermilion has developed this Website Privacy Statement (the "**Privacy Statement**"), which applies to the personal information that is collected, used and disclosed on Vermilion's website.

By using this website, you are consenting to the collection, use and disclosure of your personal information in accordance with the terms set out below, and acknowledging that you are over the age of 16. You may modify or withdraw your consent at any time, subject to legal or contractual restrictions and reasonable notice, by contacting our privacy officer in the manner set forth below.

What is "personal information"?

For the purposes of this Privacy Statement, personal information means any information about an identifiable individual for example:

- Name;
- Contact information (for example, home address and personal phone number, and email address);
- ID numbers; and
- Date of birth.

What personal information do we collect?

We collect and maintain personal information of visitors to this website only when it is submitted voluntarily, and we limit the use of this information only for the purpose stated. For example, we will use your Personal Information if you subscribe to receive news releases or if you set personal preferences for webcast services or other communications.

When do we disclose personal information?

Vermilion uses and discloses your personal information as described in this Privacy Statement and for any additional purposes for which we have obtained your consent to the use of your personal information.

Vermilion may disclose your personal information to employees and other parties who may require such information to assist us in establishing, maintaining and managing our relationship with you.

Vermilion automatically collects statistics about internet service networks used to access our site, including the IP address and domain used to access our website, the type and version of your browsers, the website you came from to access our website, the page you entered and exited at, any website page that is viewed by that IP address and what country you are from. This information that is collected is used for a number of different purposes including tracking the number of visitors to the site, monitoring our website's performance, and for our business purposes such as working to continually upgrade our website.

How do we use "Cookies"?

When you visit the website, Vermilion places a "cookie" on the hard drive of your computer to track your visit. A cookie is a small data file that is transferred to your hard drive through your web browser that can only be read by the website that placed the cookie on your hard drive. The cookie acts as an identification card and allows our website to identify you and to record your passwords and preferences. The cookie allows Vermilion to track your visit to the website so that we can better understand your use of Vermilion's website so that we can customize and tailor the website to better meet your needs.

Most web browsers are set to accept cookies. However, on most web browsers you may change this setting to have your web browser either: (1) notify you prior to a website placing a cookie on your hard drive so that you can decide whether or not to accept the cookie; or (2) automatically prevent the placing of a cookie on your hard drive. It should be noted that if cookies are not accepted, you may not be able to access some of the web pages found on the website.

How is your personal information protected?

Vermilion endeavors to maintain physical, technical and procedural safeguards that are appropriate to the sensitivity of the personal information in question. These safeguards are designed to prevent your personal information from loss and unauthorized access, copying, use, modification or disclosure. Unfortunately, data transmissions over the internet are not 100% secure. As a result, while Vermilion strives to protect your personal information, we do not represent, warrant or guarantee that personal information will be protected against loss, misuse, interception or alteration and do not accept any liability for personal information submitted to us via the internet, nor for your or any third parties' use or misuse of personal information.
